Legislative Update

I wanted to give you an update on the work of CO-PACT since it has been awhile. Nothing happened during the legislative session that ended in March that impacted us. There were a few bills that may have, but they didn't go anywhere.

During the interim time we are trying to meet with legislators to let them know of the work we are doing and who we are--they need to be educated. Elizabeth has been doing a fabulous job of helping this "branding" process. She is also part of a workgroup on reimbursement issues and one on network adequacy-- an idea close to my heart. As these groups solidify we will be inviting others to join the work and letting you know if bills will be forthcoming. The reimbursement group was called into existence by legislation from the last legislative session. It is spearheaded by Psychologists and Nurses who are seeking reimbursement parity with Psychiatrists for the same levels of care. We are part of that work group and are pushing to be included in the legislation.

The Affordable Care Act has mandated all states to produce network adequacy regulations if they are receiving federal funds. The challenge is to find a way of regulating adequacy that the insurance industry will buy into. Part of this effort has to do with access to panels and transparency, (to see behind the curtain). The goal of the task force that the governor has formed and we are part of is to create legislation around these issues. We will keep you posted on how this work is going.

HELP!!!!! Here is way you can help. If you hear of people that are having a difficult time finding a therapist to meet their needs within their insurance company, please let us know, this is important information to have as we negotiate adequacy. Also, we understand that some panels are "officially" closed and yet people are getting in. If you hear about those kind of situations please let us know. You can pass that information on to me at stephen.rodgers57@gmail.com

An ongoing issue with OBLPCT is around sexual impropriety for non-licensed people who are engaged in counseling/therapy/coaching who are not under the purview of the board. We have added some language (very narrowly defined) to the practice act that would not allow anyone to use combinations of terms: professional, counselor, couples, marriage, therapist, family. We are also looking into other strategies to help the board out without watering down our titles.

We are always looking for LPC's, LMFT's, interns, and students to become part of COPACT, so if you are interested in political work (does not take up much time) please let me know and I will keep you in the loop and let you know of our meetings. The next one is in September.




